The school plan was developed using a comprehensive needs assessment that included an analysis from the California School Dashboard and the district's Performance and Targeted Action Index. It is written, in part, in response to Rosemont's ATSI designation, which reflects that several students groups (African American, Students with Disabilities, Students who are socioeconomically disadvantaged, and students designated as two or more races) have been performing in the low category for suspension rates and also for CAASPP (English Language Arts and Math) for two consecutive years. The School Site Council will monitor the implementation of the plan by reviewing measurable outcomes every quarter. The school plan is aligned to the goals of the SCUSD LCAP for academic achievement, college and career readiness, and student and family engagement.

School Site Council has analyzed a variety of data and conducted the SPSA Mid-Year Review on 1/12/23. The math department met to discuss revision of current Goal1 to reflect ATSI requirements. Rosemont's MTSS team has met to analyze attendance data and discuss ideas for change. which will be reflected in our 23-24 SPSA.

Although enrollment has stayed relatively consistent, Rosemont had a reduction in staff of 1.0, which resulted in the need to re-allocate funds to maintain the required number of sections in several content areas.

Identified Need

1. DOCUMENT NEEDS ASSESSMENT
 Math proficiency continues to be a primary concern here at Rosemont. In 2022, 29% of SED students met or exceeded standards in ELA and 10% met or exceeded standards for math. 26% of African American students met or exceeded standards for ELA, and 4% met or exceeded standards in math. 44% of students designated as two or more races met or exceeded standards in ELA AND 10% met or exceeded standards in math. 10% of Special Education students met or exceeded standards in ELA, and 5% met or exceeded standards in math. There is a need to improve student outcomes for these student groups, who have under-performed for two consecutive years. (Add data for all low-performing)

2. DOCUMENT PROBLEM STATEMENT

Goal 2

Create a more welcoming and inclusive environment for all students, as measured by 10% reduction in suspensions, an increase in positive climate survey responses by 10% and a reduction of chronic absenteeism by 10% by June, 2024.

Identified Need

67% of students responded positively on the belonging/connectedness questions on the 2020-21 Fall Climate Survey. In the fall of 21-22, we used a different survey, but 75% of students responded positively to questions about connectedness and belonging. On the 2021-22 survey, 81% of students felt that students at Rosemont are accepting of people from different backgrounds and cultures. Kelvin Pulse Survey data shows improvement, over time, in students perceptions about emotional safety, self-awareness, emotional regulation, and adult relationships.

There is a need to reduce suspensions for all students, with a focus on SED students, African American students, students who identify as two or more races, and Special Education students.

The district attendance goal is 95%, and Rosemont students rarely meet that goal except for the first month of School. The rate is lowest during the months of December and February. Our current chronic absentee rate is 31%. As of March, 2023, the attendance rate was 89.6%. In February, 2022, the chronic absenteeism rate was 37.7%., so there has been some improvement. Rosemont staff must continue to focus on explicit instruction around social and emotional learning competencies and use alternatives to suspension for all but major infractions.

Approximately 5% of staff members conducted home visits for incoming freshmen. We did communicate with parents about all campus activities, parent information nights and opportunities for parent involvement through parent organizations like PTSA, Boosters, and Rosemont Music Boosters.

We did not meet our goal of home visits for all incoming freshman. Only two teachers participated in this effort during 22-23.

In 2022, 32% of students met or exceeded standards on CAASPP. 41% of white students met or exceeded standards, 29% of SED students met or exceeded standards, 26% of African American students met or exceeded standards, 24% of Hispanic students, 44% of students designated as two or more races met or exceeded standards standards, and 10% of Special Education students met or exceeded standards. There is a need to improve student outcomes for these student groups, who have under-performed for two years in a row.

Single School Districts and Charter Schools Identified for School Improvement

Single school districts (SSDs) or charter schools that are identified for CSI, TSI, or ATSI, shall develop a SPSA that addresses the applicable requirements above as a condition of receiving funds (EC Section 64001[a] as amended by Assembly Bill [AB] 716, effective January 1, 2019).

However, a SSD or a charter school may streamline the process by combining state and federal requirements into one document which may include the local control and accountability plan (LCAP) and all federal planning requirements, provided that the combined plan is able to demonstrate that the legal requirements for each of the plans is met (EC Section 52062[a] as amended by AB 716, effective January 1, 2019).

Planning requirements for single school districts and charter schools choosing to exercise this option are available in the LCAP Instructions.
